Navjeevan Law College offers a unique integrated course, the B.A.LL.B. five-year Law program, which blends the diverse fields of Arts and Law into a comprehensive curriculum. The Collge also offers three year LL.B. Degree course and two diplomas that are, Diploma in Taxation Law(D.T.L.) and Diploma in Labour Law & Labur Welfare (D.L.L. & L.W.). During the initial three years of B.A. LL.B. five year course, students delve into subjects such as English, Sociology, Economics, and Political Science, earning a Bachelor of Arts degree. Building upon this foundation, they proceed to specialize in Law during the remaining two years, culminating in a Bachelor of Laws degree. Looking ahead, the college aims to enhance its multidisciplinary approach by introducing exciting new courses like Forensic Science, Medical Jurisprudence, and Clinical Psychology. Join us in this dynamic journey of academic exploration and professional growth!

16.Academic bank of credits (ABC):

In line with the National Education Policy (NEP) and the directives of the University Grants Commission (UGC), the Government of India, through the Ministry of Electronics and Information Technology, has initiated the implementation of the Academic Bank of Credits (ABC). Referencing the letter issued by Savitribai Phule Pune University (Exam/2022/205 dated 15/10/2022), Navjeevan Law College has notified its students about the ABC facility. Students are encouraged to open their academic bank accounts on the ABC portal (www.abc.gov.in). The response from students has been positive, and the college is actively facilitating the process of creating ABC IDs for all students. Within one or two days, the college expects to complete this task, ensuring seamless access to the benefits of the Academic Bank of Credits for all enrolled students.

17.Skill development:

The majority of students graduating from Navjeevan Law College aspire to pursue a career in Advocacy, recognizing law as a professional degree that demands a diverse set of skills for success. The college is committed to providing students with both theoretical knowledge and practical skills throughout their curriculum. One of the key activities aimed at bridging the gap between theory and practice is the Moot Court, where students engage in drafting, pleading, and conveyance, gaining invaluable hands-on experience. From their first year, students are encouraged to participate in inter-collegiate Moot Court Competitions, Debates, and Elocutions, which not only enhance their vocabulary but also bolster their confidence. Navjeevan Law College goes beyond classroom learning by organizing Seminars, inviting special guest lectures, conducting Workshops, and arranging visits to institutions such as the Supreme Court, High Court, District Court, Police Stations, Central Jails, and Forensic Labs. These initiatives provide students with exposure to real-world legal settings, enriching their understanding and preparing them for a successful career in the legal profession.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The teaching-learning process for the Law Course at Navjeevan Law College primarily occurs in English, aligning with the syllabus and examination standards set by the University. However, recognizing the diverse backgrounds of students, especially those from rural areas, the college facilitates learning in Marathi or Hindi alongside English. This approach aims to ensure that all students can comprehend legal provisions and concepts smoothly. During the COVID-19 pandemic, the college transitioned to online lectures conducted by teachers, along with special guest lectures and virtual lecture series to provide additional learning opportunities during the lockdown period. Additionally, the college has organized various online certificate courses, with one recently completed on 'Advocacy Skills And Professional Ethics' and the 'Certificate Course on Cyber Laws'. These initiatives demonstrate the college's commitment to adapting to changing circumstances and enhancing the educational experience for its students, even in challenging times.

We utilized various platforms such as PPT presentations, Zoom, and Google Classroom for online teaching and conducted a range of activities including online lectures, guest lectures, virtual lecture series, and online certificate courses. These online initiatives provided students with additional expertise and knowledge in relevant fields, enhancing their overall learning experience despite the challenges posed by the pandemic. While online education complements traditional methods, we remain committed to ensuring a balanced approach that incorporates both physical and online modes of learning to meet the diverse needs of our students.

Since Navjeevan Law College is having one grant-in - Aid division and the salaries of the teaching and non-teaching staff of the granted division are made by the higher education department of the Maharashtra State Government.
